

**I. Tuition Payment Options**

- \_\_\_\_\_ a. One payment on or before June 15, 2009 -year paid in full directly to OLPH School (receive 20 service hours credit)
- \_\_\_\_\_ b. Two payments June 15 and January 15 – 50% of year each payment paid directly to OLPH school. (receive 10 service hours credit)\* Must have Principal and school business office credit approval based on OLPH payment history for option “B”.
- \_\_\_\_\_ c. Diocesan Payment Plan (credit card or checking automatic withdrawal with no charge withdrawn or charged) on the 5<sup>th</sup> or 20<sup>th</sup> of each month.  
 \_\_\_\_\_ 10 Month (Aug. 09 thru May10) \_\_\_\_\_ 12 Month (July 09 thru June10)

**\*All Registration & Fees are due on or before 1 June** at OLPH, any remaining amounts will be added to your 10 or 12 monthly payments.

**II. Scrip Options**

- \_\_\_\_\_ a. \$400 minimum purchases a month or \$4000 a year.
- \_\_\_\_\_ b. \$400 donation (in 2 payments December 1 and May 1) to the school.
